SECTION 4 **FIRST AID MEASURES**

INHALATION: This product is not deemed to be an inhalation toxicant, however, in cases of inhalation toxication, remove person from contaminated area to fresh air.

SKIN: If in contact with skin, remove contaminated clothing and shoes. Gently wipe off excess chemical. Wash skin gently and thoroughly with water and non-abrasive soap. Seek medical attention if skin irritation persists.

EYES: If in contact with eyes, flush eyes with clean water for at least 15 – 20 minutes. Lift eyelids to facilitate irrigation. If present, remove contact lenses after 5 minutes and continue rinsing. Seek medical attention if irritation persists.

INGESTION: If ingested, seek medical attention or call a poison control centre for treatment advice. Do not induce vomiting unless instructed to do so by a poison control centre or doctor.

Do not give anything by mouth to an unconscious person. If the person is alert, rinse mouth thoroughly with water and give 2 to 3 glasses of water to drink.

IMPORTANT ACUTE EFFECTS: Maybe harmful if swallowed.

NOTE TO PHYSICIAN: This product contains Zinc Nitrate and sodium octaborate, treat symptomatically and supportively.

SECTION 5
FIRE FIGHTING MEASURES

Suitable Extinguishing Media: Use dry chemical, water fog or foam.

Unsuitable Extinguishing Media: High volume water jet.

Specific hazards: May intensify fire; oxidizer.

Special Fire Fighting Procedures: Remove spectators from surrounding area. Isolate the fire area and evacuate all personnel downwind of the fire. Fight fire from maximum distance and use unmanned hose holder or monitor nozzles. Keep upwind. Remove container from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. Do not scatter the burning material. Water can be used to cool unaffected containers but must be contained for later disposal. Contain fire control agents for later disposal. Avoid pollution of waterways by run-off from the site.

Personal protective equipment: Wear NIOSH/MSHA approved self-contained breathing apparatus and full protective gear.

SECTION 6
ACCIDENTAL RELEASE MEASURES

Personal Precautions: Avoid contact with skin, eyes, and mouth. Do not breathe in spray mist or fumes. Ventilate area of spill or leak, especially in contained areas.

Protective equipment: Refer to Section 8 for personal protective equipment to be worn during containment and clean-up of a spill involving this product.

Emergency procedures: Alert firefighting personnel, evacuate unprotected personnel and animals.

Environmental Precautions: Prevent spilled product from entering sewers, waterways or ground water. Any spillages or uncontrolled discharges into water sources should be reported immediately to the police and the Department of Water/Environmental Affairs.

Methods & Materials for Containment: Contain spilled product by diking area with sand or earth.

Methods & Materials for Clean-up: Cover contained spill with an inert absorbent material such as sand, vermiculite, earth or other appropriate material. Vacuum, scoop, or sweep up material and place the material into a clean, dry, sealable container. Label containers with the contents and dispose of according to local regulations. Do not place spilled material back in original container. Do not re-use spill material. Collect washings and add to the drums already collected. Do not flush spilled material or washings into drains or waterways. To decontaminate the spill area, tools and equipment, wash with water and suitable detergent. See section 13 for disposal considerations.

SECTION 7 **HANDLING AND STORAGE**

HANDLING

Precautions for safe handling: Avoid contact with skin, eyes, and mouth. Ensure adequate ventilation during handling and use. Do not handle broken packages without protective equipment. Immediately clean up spills that occur during handling. Keep containers closed when not in use.

General occupational hygiene: Practice good hygiene when using this material. Wash hands before eating, drinking, chewing gum, smoking, using the toilet or applying cosmetics. Worker should shower at the end of each workday. Launder all clothing before it is re-used.

STORAGE

Conditions for safe storage: Keep out of reach of unauthorised persons, children and animals. Store in its original, labelled container, tightly closed, in an isolated, dry, cool and well-ventilated area. Avoid direct sunlight for prolonged periods, don't let product freeze. Not to be stored next to foodstuffs, feed and water supplies.

Incompatible substances and mixtures: Oxidizing agents.

Packaging material: Plastic containers and drums.

SECTION 8 **EXPOSURE CONTROLS AND PERSONAL PROTECTION**

Occupational exposure limits: No occupational exposure limits have been determined for the significant ingredients in this product.

ENGINEERING CONTROLS: It is essential to provide adequate ventilation. The measures appropriate for a particular worksite depend on how this material is used and on the extent of exposure. Local Exhaust: Provide general or local exhaust ventilation systems to maintain airborne concentrations below OELs or

Waste: Open dumping or burning of this product is prohibited. Waste resulting from the use of this product cannot be reused or re-processed. Observe all labelled safeguards until container is destroyed.
